Moved by Alderman Reynolds and seconded by Alderman Jeppson to approve and place on file the minutes of the Finance Committee for November 14, 2022.

Amin Kanchwala, owner of Rosati's Pizza, for a 15-minute parking space in front of the store at 148 Gooding Street spoke in regards to his request. He currently does not have a lot of parking available for customers on their business days of Friday-Sunday. Many occupants of the apartments in the area are often using their storefront parking. He is looking for a spot for his customers that are there for a quick pick-up order and do not have to run across the street in the weather elements. Rosati's is open 10am-9pm Sun-Thurs and 10am-10pm Fri-Sat.

Alderman Crane mentioned rolling out a sign out only during business hours. He did remind the aldermen that they are open 7 days a week for approx. 12 hours each day.

Deputy Clerk Brent Bader did send out letters in regard to this matter and the city received no response from any concerned residents.
