#### MINUTES OF THE REGULAR MEETING OF THE LA SALLE CITY COUNCIL August 27, 2018

A regular meeting of the La Salle City Council of La Salle, Illinois was held Monday, August 27, 2018 at 6:30 p.m. with Mayor Jeff Grove presiding with proper notice being duly and continuously posted.

The meeting was called to order at 6:30 p.m.

#### PLEDGE OF ALLEGIANCE

Alderman Demes revisited his concerns regarding our current ordinance pertaining to animals. He stated that since bringing his concerns forward last meeting he has heard from two groups of people, pet owners concerned about their pets being attacked by other dogs and from residents who walk and are concerned about being chased by dangerous dogs.

Alderman Demes proposed the following changes to our current ordinance:

- 1. Amend Item 2 in Section 90.15 which defines a Dangerous Dog, to read "A dog that, without justification, bites a person or animal and does not cause serious physical injury."
- 2.
- 3. \$5.00 fee for dog tags remain, but fines for non-registration of cats/dogs from amended from \$50.00 to \$750 to \$150 or \$250 to \$750.
- 4.
- 5. Transient owners/new residents should be given 30 days to register their dogs/cats.

Alderman Demes referenced Senate Bill 2386, known as Buddy's Law which addresses dangerous dogs attacking other dogs, as well as defines a reckless dog owners.

Alderman Demes also suggested that our ordinance should read that we "will" impound a dog if it is caught running loose by the Police Department. It currently reads that the City "may" impound the dog. Brief discussion continued.

Attorney McPhedran stated that the City of La Salle has had a strong ordinance for over twenty years regarding dangerous and vicious dogs and it is stronger than many surrounding

communities in regard to these matters. He continued by saying that "Buddy's Law" just signed by the Governor recently, does have provisions regarding reckless dog owners.

Attorney McPhedran believes we can use that statute as a foundation to amend our dangerous dog definition within the current ordinance as suggested by Alderman Demes because Buddy's Law does provide language for situations where a dog attacks or kills another dog. Attorney McPhedran stated that the council does have the right to raise the fine, as well as require a 30 day registration period for new/transient residents if they so choose.

In regard to the impoundment issue, Attorney McPhedran stated that there is significant expense and jurisdictional issues involved. He suggested more discussion is held with County representatives prior to any changes being made to the ordinance to ensure we are working in concert with them, not in conflict. He added that the City has a good relationship with the County when it comes to enforcement of issues.

Alderman Demes stated that we need to be pro-active in protecting our residents and pets in our City.

Chief Uranich stated that all of these ideas are good, but in reality it is difficult to find owners and impound animals. Alderman Demes stated that the main goal is to get residents to register their pets.

Moved by Alderman Demes and seconded by Alderman Duncan to have Attorney McPhedran draft an ordinance for the aldermen to review and consider at the next meeting which includes the revision of the definition of a dangerous dog to include the word animal in addition to person, to raise the fine for the non-registration of dogs/cats and to allow new residents 30 days to register their dogs/cats.

Alderman Reynolds reminded the public that they are responsible for their animals which includes cleaning up after their pets on public streets and others' private property. Violators can be fined \$50 to \$750. This also includes cleaning up after pets in dog parks.

Alderman Schneider stated that with Oglesby no longer part of the Shared Services project, he suggested that some type of procedure is put in place in the event of a tie. Mayor Grove stated that he has expressed the same concern, but hopes that if this situation were to occur negotiations would take place. Mayor Grove explained that when this concern was brought up to the attorney working with the Shared Services group, he indicated that this can be solved in some situations by a coin toss if the group were to agree to that. However, the attorney also indicated that if a point were that contentious, then perhaps it is not meant to be part of the agreement. Mayor Grove stated that on the City's end, the hope is to have issues resolved prior to a vote so as to avoid the situation in the first place.


