April 1, 2024

Immediately Following the Finance Committee Meeting - City Hall Council Chambers

Chairman Bacidore called the Meeting to order at 6:19pm

A quorum was present.

Moved by Alderman Reynolds and seconded by Alderman Crane to approve and place on file the minutes of the Streets, Alleys and Traffic Committee for March 4, 2024.

Voice vote, all ayes. Motion carried.

Chairman Bacidore began the discussion in regard to adding a "Slow - Children Playing" sign on 7th Street between Peru and Chartres St. Deputy Clerk Bader mentioned that notices were sent out to residents in the area. No one was present from the neighborhood area for or against this topic. Bader did receive two emails, one from 12 7th and 27 7th. They both had no opinion on the issue at hand but do not want the sign in their yard. Alderman Thompson stated that one of those residents also called him and they had a discussion opposing speed bumps. Alderman Bacidore had a third resident call him today and stated that the resident wasn't against addressing the issue but also did not want a sign in their yard. Alderman Lavieri stated that these type of signs do not have any legal penalty to them but he is not against putting one up if they have a spot for it.

Moved by Alderman Lavieri and seconded by Alderman Reynolds to approve adding a "Slow - Children Playing" sign at the NW corner of 7th & Chartres and SE corner of 7th & Peru.
