Priority Dispatch System Response Configuration Review/Changes

1. Brandon discussed that he did not send out the excel spreadsheets of determinants because it would be easier to explain visually. Brandon put it on the projector and discussion ensued.
2. Trouble Alarms – Contact FD AHJ
3. Confined Space – Change to FULL Still/Contact TRT, Hazmat, Water Team)
4. If we don't need gas or power company make sure to train department members to advise dispatch to cancel them.
5. "Reply all" to email from Brandon with the changes that you would like to be made.
6. Go Live is supposed to be at the end of April but possibly needs to be moved until May.
7. Discussed the Weather/Disaster Situation – still trying to figure out when to move to the weather protocol.
