Chairman Bacidore called the Meeting to order at 6:35 pm

ROLL CALL

A quorum was present.

Moved by Alderman Reynolds and seconded by Alderman Crane to approve and place on file the minutes of the Streets, Alleys and Traffic Committee for November 12, 2024.

Voice vote, all ayes. Motion carried.

Chairman Bacidore introduced the next agenda item regarding to add a street light on Rockwell Road at the U.S. 6 intersection. Alderman Crane asked if the requestor was here. Deputy Clerk Bader acknowledged Lenoard Keenan was not in attendance. Alderman Lavieri said there's a light across the highway. Alderman Crane asked to move forward to get a cost estimate.

Alderman Ptak estimated that the change would result in gaining two more parking spaces for the residents, with both parties agreeing on the new boundary.

Moved by Alderman Crane and seconded by Alderman Jeppson to get a quote from Ameren Illinois to determine the cost of adding a streetlight on Rockwell Road at the U.S. 6 intersection.

noted the lights may not address the issue and neighbors may have issues with flashing lights. Alderman Jeppson asked if a notice had gone out regarding this request. Deputy Clerk Bader noted that a notice had gone out and no feedback had been received. No one in attendance came forward to discuss the issue.

Moved by Alderman Crane and seconded by Alderman Reynolds to deny the request for flashing lights on the Pershing and Creve Coeur intersection stop sign.
