The Illinois Valley Regional Dispatch Board (IVRD) Law Enforcement Operations Committee met at 9:00 a.m., Tuesday, January 28, 2025 at the Peru Municipal Building, 1901 4th Street, Peru, Illinois.

MEETING MINUTES**CALL TO ORDER:**

The committee meeting was called to order at 9:05 a.m. by Chairman Bernabei.

MINUTES:

Chief Margis made a motion to approve the Law Enforcement Committee minutes from September 18, 2024. Chief Raymond seconded the motion. All in favor, motion carried.

NEW BUSINESS

- **Bi-Monthly Law Enforcement Meeting Schedule**

Motion to approve bi-monthly Law Enforcement meeting schedule by Raymond. Second by Curran. All in favor, motion carried.

- **Silent Dispatch:** A group discussion on silent dispatch. Raymond requested a change to the dispatch radio procedure. Request to give the location instead of the call number. This request is due to administration not having computers in cars and when officers are not in the vicinity of the computer to better allocate resources. Miller also inquired if each department has a policy on silent dispatch. The consensus is no. Miller requested that we draft a policy for each department to adopt for consistency. Miller also indicated that he would need to draft a policy to coincide with law enforcement policies. It is felt that this will improve communications and assist when we go live with the new CAD. Raymond and Miller will seek out example policies from Central Square CAD agencies.

- **Central Square CAD:** Miller gave a brief update. The first payments have been made. A kick-off meeting was held. The servers have been delivered. Connecting Point is actively working on networking and ensuring CJS requirements. We should start the building in March, and we are slated to go-live in early October.
- **10-61 Procedures:** Miller and Hunter indicated there are some inconsistencies in TC's advising officers to 10-61. This may stem from previous management requirements and training. After a group discussion, it was decided that for officer safety reasons, if a 10-28 or 10-27 comes back suspended or revoked on a traffic stop and the officer asks for the response, then please 10-61 or ask if the officer is secure first. Then go ahead with the information. Same as the subject has any Office Safety information that comes back on LEADS.
- **Priority Dispatch:** There were no changes to any Priority Dispatch definitions, critical information, jurisdictional or operational questions, or responses.
