

## **MINUTES OF THE REGULAR MEETING OF THE LA SALLE CITY COUNCIL**

**April 14, 2025**

**A regular meeting of the La Salle City Council of La Salle, Illinois was held, Monday, April 14, 2025, at 6:30 p.m. with Mayor Jeff Grove with proper notices being duly and continuously posted.**

**The meeting was called to order at 6:30 p.m.**

### **PLEDGE OF ALLEGIANCE**

### **COMMENTS**

Mayor Grove opened the floor for public comment, allowing residents to share their thoughts and concerns.

Dawn Hicks discussed a proposal to get student volunteers from LP High School and IVCC to help elderly and disabled residents with yard work. Hicks also shared positive news about the possibility of honoring veterans and first responders with banners, despite initial concerns between Ameren and the City of La Salle. Hicks would like to work with Mayor Grove on finalizing plans to honor veterans and first responders.

Dena Hicks inquired about the process of joining a city committee and expressed interest in participating. Dena Hicks also mentioned a parking ordinance regarding alley parking and seeking clarification on restrictions. Police Chief Mike Smudzinski explained the complexities of alley parking and mentioned that he will discuss it further after the meeting.

Moved by Alderman Lavieri and seconded by Alderman Thompson to accept, approve, and place on file the Building Inspector's Report for March 2025 showing total fees collected of \$3,341.70 with total value of construction of \$602,028. Each and every alderman has a copy.

## **NEW BUSINESS**

Deputy Clerk Brent Bader informed the council about the housing grant program deadline being next Friday. Economic Development Director Curt Bedei stated that he heard that the program had an overwhelming response from qualified homeowners and encouraged residents to submit their applications by the deadline.

Alderman Thompson suggested notifying local radio stations to spread the word about the deadline.

Moved by Alderman Thompson and seconded by Alderman Lavieri to send the parking concerns on Chartres Street to the Streets, Alley, and Traffic Committee meeting in two weeks.

Deputy Clerk Bader mentioned the need for letters of support for two projects related to sewer lining and a road bike path to Rotary Park. Deputy Clerk received a unanimous straw vote from all council members to proceed with letters of support for both of the projects.

Moved by Alderman Jeppson and seconded by Alderman Lavieri to approve writing a letter of Support for an Integrated Railway Program to Illinois Governor JB Pritzker and the Illinois General Assembly.

Economic Development Director Bedei stated that the letter of support that would go to the Governor's office would be to make those aware that these types of transportation needs are lacking in the state of Illinois.

Moved by Alderman Thompson and seconded by Alderman Ptak to accept and approve the 2025 MFT Roads Project – Estimated Costs

Mayor Grove also mentioned that there was one change to one location of a project, Creve Couer to LaFayette, not LaFayette to Bucklin.

City Engineer Brian Brown also discussed the timeline for the MFT Project and the next steps for approval and bidding.
