**May 12, 2025**

**A regular meeting of the La Salle City Council of La Salle, Illinois, was held  
Monday, May 12, 2025, at 6:30 p.m. with Mayor Jeff Grove  
with proper notices being duly and continuously posted.  
The meeting was called to order at 6:30 p.m.**

**CALL TO ORDER**

**PLEDGE OF ALLEGIANCE**

Mayor Grove asked for a moment of silence in honor of Mary Kaye Happ who passed away Friday, May 9.

## **COMMENTS**

Mayor Grove opened the floor for public comment, allowing residents to share their thoughts and concerns.

Brianne Hicks expressed interest in an annual citywide cleanup effort and requested information on the City's website regarding parks, specifically St. Mary's Park and Prairie Park, be updated

Lee Pakula of Haze Smokehouse expressed opposition to allowing food trucks in La Salle. Summertime is a prime opportunity for his restaurant to make up for the slower winter months. He advocated for keeping business and profits in the local community.

Deputy Clerk Brent Bader advised Mr. Pakula that the three minutes allotted to him for public comment had expired.

Dena Hicks advocated hiring lifeguards at the public pool who could work through the entire season so the pool could remain open longer and for providing more information to the public and taking public comment prior to voting on new ordinances. She also asked how long the City can afford to transport material from the sewer line failure under the Little Vermilion River. She asked why appointments of police and fire chiefs have not been made. She commented on the state of the landscaping outside City Hall.

Deputy Clerk Brent Bader advised Mrs. Hicks that the three minutes allotted to her for public comment had expired.

Jamie Hicks noted this is his first City Council meeting after a hiatus of a year. He said he won't be silenced by Council Members and indicated his intention to file a lawsuit because of his belief he is being targeted and persecuted by Council Members.

Deputy Clerk Brent Bader advised Mr. Hicks that the three minutes allotted to him for public comment had expired.

## **DISCUSSION AND POTENTIAL ACTION ON THE FOLLOWING PETITIONS**

Mayor Grove reviewed the current rules regarding mobile food truck vendor permits. Once a permit is approved the food truck vendor is allowed to be present at 12 events for the

season. In addition, the business hosting the event must obtain a special use permit for each event. Mayor Grove suggested the Council consider at a future meeting reducing the number of events allowed for each permit.

Attorney McPhedran clarified there are two types of special permits: one regarding noise and hours and one regarding food trucks. Noise/hours permits do not currently have a limited number of events attached to them. Food truck permits allow for 12 events outside of downtown (the Central Business District). Originally no downtown food truck permits were allowed, although some exceptions have been made. Action will only be taken on specific requests tonight. Any changes to the ordinances would require notice to and the vote of the full council.

The Central Business District is defined as the area from the railroad on the east to the railroad on the west and the north side of Third Street to the south side of First Street inclusive.

William Hocking of Detour Tap at Third and Bucklin who had a request pending before the Council for this meeting joined the discussion as his request was relevant. He explained that his food truck permit request is because his establishment does not provide food and the restaurant next door won't be open until June. Once the neighboring restaurant opens, he would not be requesting food truck permits. The bands he hires are only contracted until 10 p.m. at the latest, so the noise permit extension request is to allow patrons to enjoy the outdoor patio until 11 p.m. with soft music playing and to protect them from inadvertent noise violations a few minutes after 10 p.m. The additional opportunity for revenue for his business is considerable.

Mayor Grove cautioned about setting a precedent for other bar owners in the City if extended hours for noise are permitted pursuant to Mr. Hocking's request.

It was clarified that the first event Ina Mae Grazing, LLC will attend is at the Hegeler Carus Mansion for the first of the permit request dates.

Moved by Alderman Jeppson and seconded by Alderman Thompson to approve the request from Lacey Anderson on behalf of Ina Mae Grazing, LLC for a Mobile Food Vendor Permit and related matters.

## **SPECIAL COMMITTEES**

### **OLD BUSINESS**

Discussion regarding potential amendments to City Code related to responsible bidders and related matters.

Attorney McPhedran advised Council members that this item was for discussion only. Peru and Ottawa have similar ordinances and discussions with individuals from those cities to obtain feedback prior to making decisions in La Salle is advisable. Deputy Clerk Bader indicated he would contact Peru and Ottawa officials for more information.

Attorney McPhedran clarified that the City may hire anyone for projects as long as they comply with all government rules and regulations.

### **NEW BUSINESS**

Alderman Thompson discussed issues resulting in the recent well drilling. City Engineer Brown contacted Alderman Thompson who spoke with those involved in the project. Alderman Thompson said there are a lot of variables that are out of their control, such as hitting a void as happened here. He said he understands what they are doing and why. Alderman Lavieri asked Engineer Brown to check the aquifer in relation to issues he's learned about from other communities' aquifers going dry. Mayor Grove asked for a brief synopsis from Alderman Thompson. Alderman Thompson discussed the process of drilling and when they hit a void it is called "loss of flow." He said they didn't know it was there; they are difficult to identify. Alderman Thompson said they are doing a very adequate job of mitigating that possibility.

Mayor Grove thanked Mr. Jamie Hicks for bringing the sewer line failure under the bridge over the Little Vermilion River to the City's attention. The location is difficult to see, and the failure might have gone unnoticed for some time. Tankers are hauling the sewage while the line is being repaired. Insurance does not cover the repairs and funds will be taken from the City's sewer funds.

Mayor Grove also commented on the landscaping outside City Hall. The contractor will be returning to complete the project now that the weather is cooperative.
