

**MINUTES OF THE REGULAR MEETING
OF THE LA SALLE CITY COUNCIL**

June 23, 2025

**A regular meeting of the La Salle City Council of La Salle, Illinois, was held
Monday, June 23, 2025, at 6:30 p.m. with Mayor Jeff Grove
with proper notices being duly and continuously posted.
The meeting was called to order at 6:30 p.m.**

Mayor Grove opened the floor for public comment, allowing residents to share their thoughts and concerns.

Dawn Hicks criticized Nathan Watson, the City's handling of the relationship with CL Enterprises, and the potential future business relationship with Watson and his new company Glenstone Development.

Amber French, one of the owners of Bankshots Sports Bar & Grill soon to be located in the old Illinois Valley Food Center building, discussed detailed plans for use of the building converting it into a family friendly billiards hall, restaurant, and bar. The building is 28,000 square feet.

Kerry Izzo-Dauber of the La Salle Speedway thanked the council for Special Permits approved by the Council at the previous meeting.

Deputy City Clerk Brent Bader indicated there was an error on one of the dates in the previous request by La Salle Speedway for Special Permits for extended noise hours. Wednesday, September 3 should have been Saturday, September 13. In addition, the Sunday, August 17 event is scheduled to conclude by 6 p.m., making a permit for that day unnecessary. Bader requested a straw vote for the September 13 permit request; the straw vote indicated the council will be inclined to approve the request when formally made.

NEW BUSINESS

Moved by Alderman Lavieri and seconded by Alderman Thompson to forward the Petition for Annexation and Rezoning of Donald L. Ashley, Trustee under a Trust Agreement dated July 5, 2001, and Sue M. Ashley, Trustee under a Trust Agreement dated July 5, 2001 (premises in the vicinity of the corner of Chartres Street and Wenzel Road) to the Planning Commission for review.

Bader discussed the ordinance issues for the proposed billiards hall in the former IV Food Center: a limit on the number of pool tables and signed waivers by a parent required for minors present in a billiards hall. Bader suggested reviewing the ordinances and identifying necessary changes. Attorney McPhedran indicated state gaming ordinances would also need to be reviewed.

Alderman Herndon asked Amber French if she planned to have gambling in the business.

Moved by Alderman Herndon and seconded by Alderman Lavieri to give Ms. French time to speak further to the Council from the podium regarding her plans. She described intended locations, times of operation, and equipment available in the building. She is applying for a gaming license through the state.

Economic Development Director Bedei provided an update on the North Central Illinois Council of Governments (NCICG) home rehab project. It is entering the next phase where work on the homes will begin.

Bader indicated Katherine Orsini from FYA had requested a raffle license a few hours ago for an event Saturday, June 28 in partnership with the Food Pantry. As a new business owner, he was unaware of the process for obtaining a license. A straw vote was taken, and it was agreed to grant the license in the interest of supporting community non-profit organizations and in the hope that future requests will be in keeping with the required timeline.

Alderman Lavieri asked for clarification on the practice of the Mayor voting on various motions throughout the meeting. Bader explained this issue was discussed at a recent municipal clerk seminar. The cities of Peoria and Normal were cited as examples where the mayor's votes are marked in both the minutes and on the ordinances. The purpose is that the public then knows where the mayor stands on various issues.

Mayor Grove shared the news that Police Chief Mike Smudzinski has provided notice of retirement with his last day to be October 10, 2025. The Mayor spoke of the Chief's exemplary 28-year commitment to and service of the City. La Salle native Jason Stubler who currently serves as a Commander in the City of Naperville will be the new chief beginning October 6, 2025.

Smudzinski updated the Council on the receipt of \$45,102.13 grant from the State for body cameras, squad cameras, and storage. Docking stations are not covered; the cost is approximately \$900.
