OF THE LA SALLE CITY COUNCIL

**August 18, 2025**

**A regular meeting of the La Salle City Council of La Salle, Illinois, was held  
Monday, August 18, 2025, at 6:30 p.m. with Mayor Jeff Grove  
with proper notices being duly and continuously posted.  
The meeting was called to order at 6:30 p.m.**

**CALL TO ORDER**

**PLEDGE OF ALLEGIANCE**

**COMMENTS**

Mayor Grove opened the floor for public comment, allowing residents to share their thoughts and concerns.

Michelle Mathia of 325 Fifth Street expressed concern over speeding along Fifth Street. Previously there had been an issue there with high school students parking, often blocking driveways and interfering with garbage pickup. That has improved; however, with the new school year starting adult drivers often speed by despite the school zone sign.

Jake Palmiter reiterated his and his wife Alyssa Salas' interest in the 500 Second Street building. He reviewed his qualifications, experience, community commitment, financing, and developing business plan.

Alyssa Salas discussed plans for coordinating their ownership of 111 Bucklin and potential ownership of 500 Second Street. Plans include creating a multi-use facility with a kitchen, event space, parking, facades, windows, arcade, Airbnbs, etc. all within a two-year period.

## **OLD BUSINESS**

Moved by Alderman Reynolds and seconded by Alderman Thompson to authorize payment of Pay Request #25 from Vissering Construction Company totaling \$125,411.16 for work completed to date on Aerobic Digester Conversion project and related matters.

Alderman Demes indicated he and Alderman Thompson discovered a rental property in their ward disguised as an Airbnb with nine people living there for more than 30 days. Alderman Demes indicated he would like this topic to be a future agenda item. Attorney McPhedran responded that this had been an issue in the past and would be looked into again.

City Engineer Brian Brown reviewed the status of the road project. Completion is anticipated by the end of the week. Brown indicated he has completed a design for a water main replacement from Eleventh Street to Chartres.

Economic Development Director Curt Bedei provided an update on the Federal EPA (Environmental Protection Agency) initiative called GLO (Get the Lead Out). GLO representatives recently knocked on local doors to ask residents about their service lines and to recruit volunteers to provide water samples.

Traffic in the 300 block of Fifth Street was discussed. Chief Smudzinski indicated he has officers in the area and asked Ms. Mathia to stay briefly after the meeting to provide more information to assist in their efforts.

The Chief reported efforts at Fifth and Bucklin to monitor traffic appear to have been effective.

Alderman Herndon asked for an update on the status of the Internet project. Mayor Grove stated conversations are continuing with SURF and Geneseo Communications.

Alderman Thompson asked for an update on the well project. City Engineer Brown indicated the project is progressing smoothly with rock formations as hoped. They are currently at about 1,100 feet and need to get to 3,000 feet. It will be in the same aquifer as Peru's well so the volume is anticipated to be comparable to Peru's.

## **NEW BUSINESS**

Mayor Grove reviewed the history of the public works building at 500 Second Street which was appraised at \$275,000. Initially no one was interested in it. Then the Council decided to go through a Request for Proposal (RFP) process. No parties were able to offer a complete RFP application, with Mayor Grove noting the evidence of financing for proposed projects was an important component needed. Then, a proposal came from Mr. Nathan Watson; it was reviewed by a subcommittee of Finance Director John Duncan, Economic Development Director Curt Bedei, and Deputy Clerk Brent Bader. It was then moved forward to the Council. During that time the Council remained open to other proposals and today one was brought forward, although it is incomplete at this time. The Mayor expressed the opinion that Mr. Watson's proposal is a viable project, ready to go, and should be considered.

Attorney McPhedran stated that from a legal perspective the Council has the discretion to take whatever action it deems just and appropriate, pursuant to consult with the City's TIF counsel Attorney Herb Klein, that is in the best interests of the City of La Salle and the public at large, whether that to be to move forward tonight with the Ordinance or to wait longer. McPhedran explained it is Attorney Klein's opinion that pursuant to the TIF Act this action must be passed as an Ordinance by the corporate authorities of the municipality. The ordinance should receive a majority vote including the Mayor and the Aldermen. The more votes there are in favor of it, the stronger the legal foundation for it.

## **DISCUSSION AND POTENTIAL ACTION ON THE FOLLOWING ADDITIONAL ORDINANCES/RESOLUTIONS:**

Alderman Thompson requested clarification on a 50/50 split. Attorney McPhedran responded that the developer would not be seeking those types of TIF benefits with regard to this development. The TIF benefit in this agreement is for the acquisition of property and if the developer completes the project in a timely manner the price does not need to be paid. There is no other TIF benefit promised. Attorney McPhedran asked Mr. Duncan and Mr. Bedei if they concurred with that interpretation and they agreed.

Further discussion clarified there is a 50/50 split on the Environmental Phase II inspection. Under the agreement, the City will pay half of the inspection cost up to \$5,500. If the transaction proceeds to closing, the City will be reimbursed for the cost. However, if there is no closing the City would retain the right to the information contained in the inspection report. Investing in the inspection report provides the City with the ability to be transparent going forward.

Moved by Alderman Reynolds and seconded by Alderman Ptak to approve an Ordinance approving and authorizing the execution of a Tax Increment Financing (TIF) Redevelopment Agreement, including, but not limited to, the transfer of City Real Estate by and between the City of La Salle and Glenstone Redevelopment, LLC and Nathan L. Watson. (Involves Real Estate at 500 Second Street)

Mayor Grove thanked everyone for their efforts on this project.

Deputy City Clerk Bader indicated Alderman Demes had spoken to him about the nuisance ordinances and violation fees associated with it and stated there may be review of this in the future. Attorney McPhedran explained there may be limits of \$750 or \$1,000 on fines; however, for each day of violations there may be a separate fine. In addition, each section of the ordinance may be considered an independent violation. Continuing violations can add up. Alderman Demes stated fines do not appear to be a deterrent and should be reviewed.

Attorney McPhedran asked that it be included in the record that Jake Palmiter and Alyssa Salas who were interested in presenting a proposal for the 500 Second Street building, as well as Nathan Watson of Glenstone Development, were present for the entire discussion during tonight's meeting.

Illinois Valley Chamber of Commerce Executive Director Bill Zens was also present for discussion amongst the Council.

## **EXECUTIVE SESSION**

Mayor Grove stated there was no need for an executive session.
