Monday, October 13, 2025, at 6:30 p.m. with Mayor Jeff Grove
with proper notices being duly and continuously posted.
The meeting was called to order at 6:32 p.m.**

OLD BUSINESS

Moved by Alderman Lavieri and seconded by Alderman Jeppson to authorize payment of Pay Request #8 for Municipal Well & Pump totaling \$546,270.52 for work completed to date on 2024 Water System Improvements/Deep Well Drilling project and related matters.

Alderman Thompson provided an update on the project indicating they had hoped to have water flowing today; however, due to the need to repair damaged threads on the pipes there is a delay until probably next week. City Engineer Brown clarified that the damaged pipes belong to the Municipal Well & Pump, not the City, and are not a permanent part of the project.

Alderman Ptak asked at what depth water was found; Brown indicated approximately 2,650 feet. Brown anticipates it will be possible to pump as many as 1,500 gallons per minute.

NEW BUSINESS

Alderman Lavieri advised the Council he received a call from a resident expressing concern about motorists frequently speeding through the stop signs at the T intersection at Garfield and Prospect. Mayor Grove suggested placing the speed limit monitor there to discourage the speeding. Other options were discussed as well including additional enforcement.

Alderman Ptak raised the issue of electric scooters and eBikes. Police Chief Jason Stubler provided an update on the new legislation regarding rules of the road for scooters and eBikes. Following discussion, the consensus was that before creating any new ordinances in this matter the approach should be to enforce state law and revisit the matter as necessary.

Alderman Ptak asked about the installation of fiber optic on poles by Comcast. City Engineer Brown indicated that aerial fiber optic is not what the City is seeking and the installation is probably for a specific location only.

Mayor Grove asked Chief Stubler for an update on the installation of the new CAD (Computer-Aided Dispatch) system. Stubler indicated it was launched Tuesday and

thanked everyone involved in its implementation. He stated it is a robust product that manages inventory, personnel, evidence, etc.

Mayor Grove discussed a power outage earlier in the afternoon which might have been caused by a semi hitting a light pole near Lighted Way. Power has been restored.

DISCUSSION AND POTENTIAL ACTION ON THE FOLLOWING ADDITIONAL ORDINANCES/RESOLUTIONS:

Deputy City Clerk Bader clarified that the following ordinance relates to Hoover Real Estate and Alexandra Hoover at 901 First Street, the former Office Supply building.

Alderman Ptak asked if there was a timeline on the agreement. Alexandra Hoover indicated they have extensive restaurant experience and intend to open a fine dining, American cuisine restaurant by the end of spring.

Moved by Alderman Reynolds and seconded by Alderman Ptak to authorize an Ordinance approving and authorizing the execution of a Tax Increment Financing (TIF) District Redevelopment Agreement by and between the City of La Salle, La Salle County, Illinois and Hoover Real Estate Ventures, LLC and Alexandra Hoover. Each and every Alderman has a copy.
