NEW BUSINESS

City Engineer Brown indicated LP High School has bid out the construction of part of the new Agricultural Building at Sixth and Creve Coeur. Short term closures of Sixth Street will be necessary to move equipment and materials. Flagger people will be present during the moves; however, the street will only be closed during the movement of materials, not for full day. Construction will begin as soon as possible.

There is no update on obtaining new fiber service. A list of six possible providers is being worked. Leaf vacuums are out in full force. The yard waste drop off usually closes the first week of December. Celebration of Lights is open nightly 5-9 p.m. through January 1.
