CALL TO ORDER

Chairman Ptak called the meeting to order at 6:00 p.m.

ROLL CALL

APPROVAL OF MINUTES

Moved by Alderman Reynolds and seconded by Alderman Herndon to approve the minutes of the Finance Committee meeting from the November 24, 2025, meeting.

Voice vote, all ayes. Motion carried.

DISCUSSION AND RECOMMENDATIONS

Kevin Lindeman, Executive Director of North Central Illinois Council of Governments (NCICG), and James Duran, NCICG's new Economic Development Planner, discussed NCICG's services available to members including regional development, infrastructure development, economic resiliency, and workforce. Organizing speakers on various economic development issues, data gathering, and navigating grant opportunities are also functions of NCICG. Recent projects involving NCICG include Stevenson Road (Ottawa) road improvements, the new agricultural building at IVCC, and a deep sewer project in Peru. Lindeman indicated that the City has likely been involved with NCICG since its inception in 2006.

Economic Development Director Curt Bedei indicated NCICG recently assisted the City with the housing rehab grant and lead line funding. The annual membership fee is \$3,000.

Moved by Alderman Reynolds and seconded by Alderman Lavieri to recommend to the Council to approve renewal of membership to the North Central Illinois Council of Governments at a cost of \$3,000 and related matters.

DISCUSSION AND RECOMMENDATIONS

Alderman Lavieri inquired about the Ford Utility Interceptor being a hybrid. Police Chief Jason Stubler indicated the proposed vehicle is not a plug-in. It is a standard hybrid model which automatically recharges the battery as it gets low. The hybrid unit will reduce idle time, includes regenerative braking resulting in fewer brake changes, and reduces maintenance expenses overall. The funds for purchasing the vehicle will come from the general fund.

Moved by Alderman Herndon and seconded by Alderman Reynolds to recommend to the Council to approve the purchase of a 2026 Ford Utility Interceptor for the Police Department at a cost of \$44,886.70 and related matters.
