All Police and EMS personnel are encouraged to attend, as we will be discussing the transition to Illinois Risk Level 2 responses, which may include Police and EMS responses with mobile Crisis Response teams.

**Staffing:** Abby Mumm will be released and assigned A night rotation beginning January 4, 2026. Kamdyn Becket continues to excel through her training and has been working afternoons to gain experience. When Abby is released, we will be hiring another part-time person.

**CAD:** CAD gets better by the day. TCs are building muscle memory, which is improving. There are still some gaps that are being addressed through reporting in the new system. Agencies are encouraged to get any issues over to us via the Field Feedback Reports so that they can be formally addressed. We are addressing issues via Central Square Support as there are a few lingering issues after go live which include total phone integration and livescan.

**Legislative:** Representative Briel was at IVRD a few weeks ago and has pledged to cosponsor a bill to raise the 9-1-1 surcharge from \$1.50 to \$2.50 which would have a profound impact on IVRD financially. There has been some movement as the NENA/APCO lobbyist is working with some legislator's down south to move this forward.
